# CREATIVE ARTS SHOW

#### **Show Summary**

- All students who enter the horticulture show will be judged together, no matter the species of plant.
- The Grand Champion & Reserve Champion will be awarded buckles & an Auction Sale lot. These projects will be auctioned on Saturday, April 27<sup>th</sup>, and the proceeds will go directly to the student.
- Additional Sale lots may be created at the Ag Teacher's discretion.

#### Lamar FFA Creative Arts Show Rules & Regulations

#### **RULE 1: GOVERNING RULES**

All entries and awards are subject to the General Rules of the Lamar FFA Show & Auction. All Rules must be adhered to or the project will be disqualified. Please read all the rules before proceeding.

#### **RULE 2: APPLICATION FOR ENTRY**

All Entries must be entered by the due date. Forms not completely filled out will not be accepted and the entry fee will be forfeited.

RULE 3: ALL CREATIVE ARTS ENTRIES MUST BE SUBMITTED BY MONDAY, APRIL 1<sup>ST</sup>, 2024, TO MR. IBRAHIM(J111). CULINARY ARTS ENTRIES TO MR. IBRAHIM(J111).

#### **RULE 4: ELIGIBILITY**

All Lamar students are eligible to participate in the show **if** they are meeting all UIL eligibility standards at the time of the show. Students will be required to submit an eligibility form at check-in for verification.

**RULE 5: ENTRY FEES** The entry fee is \$10.00 *per* entry, which is due **WITH** show entry form, on April 1<sup>st</sup>, 2024. Only one entry per show, per exhibitor is allowed. (EX.-Student may enter one Creative Arts item and one Cook-Off team but not 2 Creative Arts items).

#### **RULE 6: EXHIBIT ENTRIES AT SHOW**

All Arts Show entries are to be checked in between 3:00 p.m. and 4:00 p.m. on Thursday, April  $25^{th}$ , 2024, **IN THE GRAND HALL.** NO ENTRIES WILL BE ACCEPTED BEFORE OR AFTER THIS DATE AND TIME.

#### **RULE 7: ENTRY REQUIREMENTS**

- A. All articles must be made by one individual and only by the person whose name appears on the entry card. **Projects made by groups or organizations will not be accepted.**
- B. ALL ENTRIES MUST BE OF APPROPRIATE SIZE, AS INDICATED BY EACH SHOWS' REQUIREMENTS
- C. All art pieces must have been made within the last year prior to the current Show (May through April), and not previously entered in the Lamar Show.
- D. ONLY one entry will be accepted in each Show. Two entries for the same show will NOT be accepted.
- E. EVERY EXHIBITOR is required to submit an eligibility form for each entry. One original form may be used, and copies of that form will be accepted as long as the original is on file with the Show coordinators. PLEASE HAVE A COPY OF THIS FORM AVAILABLE DURING CHECK-IN.

#### Lamar FFA Creative Arts Show Rules & Regulations

#### **RULE 8: REGISTRATION COMMITTEE**

The registration committee reserves the right to accept or reject any entry depending on conditions and suitability for exhibit. The committee has the right to reclassify any exhibit. Entries will be exhibited subject to available space at the discretion of the Show Superintendent.

#### **RULE 9: JUDGING**

Judging will be done by highly qualified judges whose decision will be final. Committee Members will not be eligible to judge or work in the Show in which they or their children are exhibiting. Each show will be judged by Class. Ribbons will be given as follows: 3 Judging will be closed to the public; exhibitors cannot be present during the judging.

#### **RULE 10: AWARDS**

- A. Ribbons will be awarded to all participants.
- B. Best of Show ribbons will be awarded in each Class
- C. Grand Champion will be awarded to the best entry from each Show
- D. Reserve Grand Champion will be awarded to the second-best entry from each Show

#### **RULE 11: LIVE AUCTION**

Only Grand Champion and Reserve Champion Creative Arts will be in the Live Auction. Entry application **MUST** indicate YES or NO for the auctions. If the exhibitor wishes to sell in the Live Auction, the items **MUST** be checked on the entry form, if an item is selected by Judges.

#### **RULE 12: PICKING UP EXHIBITS**

- A. All entries not picked up by 7:00 pm on Thursday, will become the property of the Lamar FFA.
- B. Those selling in the live auction will be directed to return or relocate their item to a designated location at the time of their release.

### Creative Arts Show Special Rules

#### **RULE 1: ENTRIES**

Entries will be accepted for the following Classes: (DUE Monday, April 1st, 2024)

**Class 1: Paintings -** Acrylic, Watercolor – tempera, gouache, casein (Spray Paints also included). All work must be DRY.

**Class 2: Inks & Drawings -** Work may be on any prepared surface. Ink Drawings may include colored ink and felt tip drawings. Pencil, and Crayon and must be protected with cellophane.

**Class 3: Photography-** Work may be done with any type camera, may be black and white, or color. Work must be printed on 8" X 10" photo paper and mounted on black mounting board. Digital manipulation of original photo is allowed.

#### **RULE 2: SIZE**

- 1. Art Pieces must be no smaller than 5" x 7" or larger than 18" x 20".
- 2. ALL PAINTINGS, INKS, DRAWINGS, and other TWO-DIMENSIONAL work MUST BE mounted to an art board. Paintings on canvas may be mounted.

#### **RULE 3: PROJECT REPORT**

A diary/report, with pictures, must accompany all entries and must be signed by a Lamar FFA Advisor or Registration Committee member. A **minimum of five (5) photos** for paintings/drawings showing different stages of the project must be included. Diary/report format will be provided by the Superintendent in advance to the show. **NO SCRAPBOOKS.** 

#### **RULE 4: AUCTION**

Due to limited space, only Grand Champion and Reserve Champion winners are guaranteed to be auctioned. All profits made in the auction will go to the artist.

#### **RULE 5: GRAND & RESERVE CHAMPION**

Grand & Reserve Champion winners will be required to prepare their entry before the Live Auction on Saturday, April 29th, 2023. Preparation is at the winner's expense, but there are no limitations to type, style or size of frames, mounts, etc.

#### **RULE 6: BUYERS**

All exhibitors who sell their items at the Live Auction will be required to forgive ownership of the items which will be taken by the owner at the conclusion of buyer check-out.

#### **RULE 7: CHECK-IN**

All Arts Show entries are to be checked in between **3:00-4:00 PM** on Thursday, **April 25th**, **2024**, **IN THE WHITE TENT**. Judging will begin promptly at **4:30 PM**.

\*NO ENTRIES WILL BE ACCEPTED BEFORE OR AFTER THIS DATE AND TIME.

#### **RULE 1: GOVERNING RULES**

All entries and awards are subject to the General Rules of the Lamar FFA Show & Auction. All Rules must be adhered to or project/entry will be disqualified. Please read all the rules before proceeding.

#### **RULE 2: APPLICATION FOR ENTRY**

Each Team must enter by submitting the appropriate entry form by the entry deadline. Entry forms MUST BE ACCOMPANIED BY a despot of \$10 PER STUDENT (TOTALING \$30). Forms not completely filled out will not be accepted or considered for the contest.

#### **RULE 3: DEADLINE**

ALL ENTRIES MUST BE SUBMITTED BY TO MR. IBRAHIM ON A FIRST COME, FIRST SERVE BASIS UNTIL ALL 10 TEAMS ARE FILLED BY TUESDAY, APRIL 1<sup>ST</sup>, 2024.

#### **RULE 4: ELIGIBILITY**

All Lamar students are eligible to participate in the show **if** they are meeting all UIL eligibility standards at the time of the show. Students will be required to submit an eligibility form at check-in for verification. Cook-Off Entries are exempt from required Barn Workday hours AND Fundraising hours, as indicated in the General Show Rules, though we highly encourage participants to assist in advertising the show.

#### **RULE 5: TEAM MEMBERS**

Teams must consist of 3 eligible Lamar students AND 2 adult chaperones. The adult chaperones must be a parent, guardian, family member, teacher, or other responsible party, as approved by the Cook-Off Committee. Adult chaperones will be subject to HISD Background check if not already on file. ALL 5
TEAM MEMBERS AND CHAPERONES MUST BE PRESENT DURING THE ENTIRE CONTEST PROCESS, THIS IS AN OVERNIGHT EVENT. (Extra security will be on-site for safety & protection)

#### **RULE 6: SUPPLIES**

- A. Each student is required to submit an eligibility form in order to compete in the Cook-Off. PLEASE HAVE A COPY OF THIS FORM AVAILABLE DURING CHECK-IN on Friday, April 26th, 2024.
- B. Teams will be required to provide their own seasonings, wood & supplies for the meat and smoking process. Supplies include, but are not limited to knives, forks, seasoning applicators, utensils, cutting boards, aprons, gloves, thermometers, soap, buckets, chairs, canopy, etc.
- C. Meat, Smokers, tables & designated area will be provided & ready on-site at the time of competition.

  \*\*If you are unsure about an item or supplies, please contact an Ag Teacher\*\*

#### **RULE 7: REGISTRATION COMMITTEE**

The registration committee reserves the right to accept or reject any entry depending on completed forms, approved adult sponsors, and eligible student members.

#### **RULE 8: PRODUCT PRESENTATION**

After smoking time has been completed, Teams will have 45 minutes to present 3 plates prepared for judges and prepare serving plates for Show & Auction guests.

#### **RULE 9: JUDGING**

Judging will be done by highly qualified judges whose decision will be final. Committee Members will not be eligible to judge or work in the Show in which they or their children are entered. Judging will be held at 10:00 AM on Saturday April 27th, 2024. \*\*NOTE – There will be NO RAINOUTS.

Judging will be closed to the public.

#### **RULE 10: AWARDS**

- A. Grand Champion Team Team Buckles & \$750 scholarship for each student member
- B. Reserve Champion Team Team Buckles & \$600 scholarship for each student member
- C. Additional placing ribbons will be presented to each participating team
